Elect Board President and Vice President

Dr. Estep nominates Dr. Jerry DeGrado, D.C. for Vice President. Seconded by Dr. Durrett. Carried. By acclimation, Dr. DeGrado is the Vice President of the Board.

Dr. Varner, KSBHA President, begins presiding over the meeting.

Final approval of impaired provider contracts

Final approval of Medical Director contract

(Durrett, Estep) Motion to approve Medical Director contract. Carried.

Discuss and consider final approval of CE Broker contract.

(Durrett, Estep) Motion to proceed moving forward with CE Broker and authorization to enter into the contract upon CE Broker's acceptance of amendments from the General Counsel; and that any substantive alteration or requests to the contract must come back to the Board for consideration and approval. Carried.

PBI Presentation

Mark Schenthal and Kasey Cleary give a presentation and handout regarding PBI as an option for the agency to use for professionals who need remediation. PBI provides remedial education to healthcare professionals via virtual live classrooms. Questions from the Board.

General Counsel:

General Counsel Report

Appellate Case Update:

Michael Estivo, DO v. KSBHA - On June 17, 2022, the Kansas Court of Appeals issued an unpublished opinion reversing the District Court's Order and affirming the Board's Final Order in its entirety. In the Final Order that was affirmed, Dr. Estivo was required to attend a CPEP record keeping seminar and was assessed costs of \$32,129.50. Dr. Estivo did not petition the Kansas Supreme Court for review. This matter has concluded in the Board's favor.

Trust Women v. Bennett et al – The Attorney General's office has filed their Petition for Review to the Kansas Supreme Court. We did not file a Petition for Review. Trust Women has filed their Response in Opposition. We are waiting for an order either granting or denying review from the Kansas Supreme Court.

Bejar v. Kansas State Board of Healing Arts – Appellate briefing has concluded in this matter. On August 3, 2022, the Kansas Court of Appeals assigned this case

to the summary calendar, meaning there will be no oral argument prior to a decision. Either party has 14 days to file a motion requesting an oral argument.

KSBHA v. Shawn Parcells- We are waiting a written opinion from the Kansas Court of Appeals.

Regulation Update:

Four CNMI regulations became effective on July 8, 2022. Amended PT regulations had a JCARR hearing and public hearing and are before the Board for final adoption today. The regulation on reentry active license has received all necessary stamps and is ready to proceed. Dr. Templeton provided general comments regarding the proposed reentry active regulation.

Education and Outreach. Year to date, 28 presentations have been given, 12 more are scheduled.

(Balderston, Estep) Motion to appoint Dr. DeGrado to the CNMI Council as the Board member designated by the President. Carried.

Consider appointments for the Collaborative Drug Therapy Management Advisory Committee

The KSBHA is required to appoint three physicians, and at least two of whom have experience in collaborative drug therapy management. K.S.A. 65-1677. The KSBHA must also give consideration to any names submitted by the Kansas Medical Society. *Id*.

KMS has recommended: Dr. Erin Fast, Dr. Michael Machen and Dr. Lynn Fisher.

(Estep/DeGrado) Motion to appoint Dr. Fast, Dr. Machen, and Dr. Fisher to the Collaborative Drug Therapy Management Advisory Committee. Carried.

General Counsel report (continued):

Follow-up on S Sub for HB 2279

At the June 10, 2022, KSBHA Board meeting, the Board approved requesting an Attorney General's ("AG") opinion on the scope of S Sub for HB 2279. The request for the AG's opinion was sent the same day. To date we have not received a response. Our last update from the AG's office was that it was under review, and they would notify us when a decision is made. General Counsel provided a timeline of events since last KSBHA Board meeting on the KSBN proposed amended regulations implementing S Sub for HB 2279.

The Board's position and analysis on S Sub for HB 2279 has not changed. Point of action moving forward is twofold: (1) Submit written testimony to the KSBN during the public comment period on proposed permanent regulations K.A.R. 60-11-101, 104, 105, and 107; and (2) Proceed with our standard complaint and investigatory process and prosecute the unlicensed practice of medicine, as authorized under the Kansas Healing Arts Act.

General Counsel provided the Board information on *Vanterpool v. FCLB*, *Winkler, and Boghosian*, Case No. 1:22-CV-01208 filed in the United States District Court for the District of Colorado.
