Executive Director Report

Kansas.gov email addresses for Board and Council members are not being utilized so they will be discontinued. Question regarding encrypting email process. This will be researched for the December Board meeting.

The Board's recent letter sent out to all Kansas licensed physicians on National Physician Suicide Awareness Day was highlighted in the Sedgwick County Medical Society newsletter.

Dr. Gould has been working with the National Board of Chiropractic Examiners to review and update the Special Purpose Examination for Chiropractic ("SPEC Exam"). We anticipate having a presentation on the SPEC exam at the December Board meeting.

CE Broker update. The contract has been signed. This is a CE tracking tool which will be optional for licensees. There is an aggressive timeline for implementation. There were no questions.

Budget has been submitted and is at the Department of Budget for review before proceeding to the Legislature.

Development of Expert Witness List

KSBHA would like to develop a pool of experts and not use companies to find experts. Discussion regarding ideas, i.e., educational outreach, associations.

III. STAFF REPORTS

General Counsel:

General Counsel Report by Courtney Cyzman

Trust Women v. Bennett et al – On September 2, 2022, the Kansas Supreme Court denied the Petition for Review. The mandate was issued September 16, 2022. This matter has been reversed and remanded to the District Court with directions. A hearing at the District Court has not yet been scheduled.

Bejar v. Kansas State Board of Healing Arts – This matter has been set for Summary Calendar before the Kansas Court of Appeals on October 17, 2022.

KSBHA v. Shawn Parcells. We are waiting a written opinion from the Kansas Court of Appeals.

Currently there are 6 active Presiding Officer cases with a Board member assigned as the PO and 2 cases at the Office of Administrative Hearings ("OAH"). Questions were answered regarding the process.

Regulation Update

K.A.R. 100-6-6, Reentry active license; medicine and surgery and osteopathic medicine had JCARR on September 14, 2022, and a public hearing on September 22, 2022. The CNMI regulations have been stamped and are scheduled for JCARR on October 18, 2022, with a public hearing to follow on November 30, 2022.

Consider final adoption of K.A.R. 100-6-6. Reentry active license; medicine and surgery and osteopathic medicine.

Education Outreach

Year to date, KSBHA has given 36 presentations (many of these include both Licensing & Professionalism), with 16 additional presentations scheduled.

• Consider approval of KSBHA Board Policy #23-02 – Successful Completion of USMLE and COMLEX-USA.

At the beginning of the pandemic, both USMLE and COMLEX-USA suspended their in-person skills examinations, Step 2 CS and Level 2-PE respectively. On July 21, 2021, Step 2 CS of the USMLE was permanently discontinued. On February 11, 2021, Level 2-PE of the COMLEX-USA was indefinitely suspended. NBOME – the organization who administers COMLEX-USA—has

decided moving forward Level 2-PE will not return; but rather the assessment aspects of that exam will now be incorporated into the osteopathic medical school curriculum. This policy addresses how the permanent discontinuation of both Step 2 CS and Level 2-PE interplay with K.A.R. 100-7-1, which sets a total limitation on the number of attempts to qualify for licensure by examination.
