a. Review of Board approved version of amendment of LRT continuing education regulation K.A.R. 100-73-7. Wiebe reviews current edits to CE regulation. These have been approved by the Board and now go to the DOB, DOA and AG offices for approval. Both temporary and permanent regulations are being done. Discuss regarding if the changes are consistent with ARRT regulations. Extended discussion and questions. Council Members would like to see ARRT registered LRT versus non-registered in regulations and some reference made to ARRT compliance. Other issues brought up regarding exempted status/limited licensure and violations of unlicensed/undertrained technicians. Council was given redlined version of regulation revisions for the April meeting. Wiebe will email out a clean version of the regulations with no redline or marking of changes.
